- Facilitate the achievement of goals by the units we serve by providing the safest environment possible and eliminating unnecessary disruptions and distractions; and
- Capitalize on new technologies and service applications to make OSU-Tulsa and OSU-CHS the safest campuses within the OSU system.

# **Goals, Critical Success Factors, Objectives, and Strategies**

Goal One. We will enhance the image of OSU by making the Tulsa campuses of OSU the safest campuses in the state system.

#### **Critical Success Factors:**

- The police functions between OSU-Tulsa and CHS will be directed by a single management structure
- Electronic surveillance cameras will provide coverage to 100% of all public access areas
- The OSU police department will be accredited by the end of the 5-year period
- Combined Part I and property crimes for the Tulsa campuses will be reduced by 15% for the 5-year period
- Creation of an emergency response plan for both CHS and OSU-Tulsa campuses

#### Objectives:

**Objective 1.1:** We will implement consolidation of police functions between OSU-Tulsa and OSU-CHS.

Strategies:

- We will demonstrate cost and service benefits of police coverage versus security coverage.
- We will determine faculty and staff perceptions of the safety of each campus to enact appropriate initiatives to alter the perception.

**Objective 1.2:** Electronic surveillance and emergency notification systems will be implemented on the OSU-Tulsa and OSU-CHS campuses.

Strategies:

- Identify specific equipment and locations will be identified for cameras and detection devices.
- Requests for funding will be submitted.
- Utilize bid process to obtain necessary equipment after funding is secured.

**Objective 1.3:** There will be a reduction in Part I and property crimes (Uniform Crime Reporting) on the OSU-Tulsa and OSU-CHS campuses.

Strategies:

- Officer patrol of buildings and parking lots will be increased to deter crime.
- OSU-Tulsa and OSU-CHS employees will be educated on crime prevention.

• We will develop a community-policing program.

**Objective 1.4:** We will achieve 194 standards for certification set by the Oklahoma Chiefs of Police.

Strategies:

- A listing of standards will be obtained from the Oklahoma Chief of Police Association.
- We will meet with consultants to determine feasibility of implementing standards.
- A timeline will be developed to identify standards, budget, actions and deadlines to attain accreditation.

# Goal Two. Collaboration between OSU Police and area law enforcement agencies will be increased.

## **Critical Success Factors:**

- An emergency response and services plan will be filed with local and county law enforcement agencies by the end of FY 2005
- OSU Police will be included in area law enforcement agencies' response plans
- Joint training exercises between OSU police and other agencies will be increase to 2 per year
- Utilization of area agency officers for regular shift coverage will increase by 15%
- Local law enforcement partnerships will increase coverage on the CHS campus

## **Objectives:**

**Objective 2.1:** We will implement cooperative agreements and expand joint services between OSU Police, Tulsa Police and Tulsa County Sheriff's Office.

Strategies:

- We will review and enhance current mutual-aid agreements.
- Lines of communication between agencies will be expanded.
- Regular meeting times and communications mechanisms will be implemented for interagency activities.
